Planning application news: *the owners appealed against the refusal of their planning application to build 4 houses on the former playing field. The appeal was refused, primarily on the basis that it did not constitute sustainable development. This ruling could – indeed should – have a significant impact on other planning applications for Caynham that are still under consideration.*

Community Asset news: *the owners of the former playing field and car park asked for a review of Shropshire Council's decision to list the site as an Asset of Community Value. The review found that the decision was correct and the listing should be maintained. The owners have now appealed to the First Tier Tribunal of the General Regulatory Council. Shropshire Council and Caynham Village Hall Committee are opposing the appeal.*
